The Law The applicable legislation is The Animal Welfare (Licensing of Activities Involving Animals) (England) Regulations 2018 (hereafter referred to as the 'Regulations').
Application process The completed forms, fees and any enclosures should be forwarded to Licensing Team at the relevant Council, by email preferred: For premises located within Bracknell Forest: licensing@bracknell-forest.gov.uk Time Square, Market Street, Bracknell, RG12 1JD For premises located within Wokingham Borough: licensing@wokingham.gov.uk Shute End, Wokingham, RG40 1BN For premises located within West Berkshire: licensing@westberks.gov.uk Market Street, Newbury, RG14 5LD Once your application has been received you will be contacted with any queries or otherwise to arrange an inspection of your premises. Should your application be refused or subsequently revoked, there is a right of appeal to the First-tier Tribunal within 28 days of the decision being made.

Conditions General conditions are attached to every licence. There are also activity specific conditions. Copies of the general and specific conditions are available on the Council website or upon request from the Licensing Section. You should familiarise yourself with these conditions before making your application.

Inspections

Officers authorised by the council will inspect the premises for compliance with the Regulations and conditions, before granting a licence and without notice when a licence is in force. The standards found at the inspection and nature of activities carried out determine the length of licence issued; 1 to 3 years.

Application form

The application form consists of two parts. This form is part 1. Part 2 will be different depending upon which licensable activities you are applying for. If you are unsure about which form(s) to complete, please contact the licensing team or check the website for guidance.

Disqualified persons

The following persons may not apply for a licence as per schedule 8 of the Regulations:

- A person who has at any time held a licence which was revoked under regulation 15 of The Animal Welfare (Licensing of Activities Involving Animals) (England) Regulations 2018
- A person who has at any time held a licence which was revoked under regulation 17 of the Animal Welfare (Breeding of Dogs) (Wales) Regulations 2014.
- A person who has at any time held a licence which was revoked under regulation 13 of the Welfare of Wild Animals in Travelling Circuses (England) Regulations 2012.
- A person who is disqualified under section 33 of the Welfare of Animals Act (Northern Ireland) 2011.
- A person who has at any time held a licence which was revoked under regulation 12 of the Welfare of Racing Greyhounds Regulations 2010.
- A person who is disqualified under section 34 of the Animal Welfare Act 2006.
- A person who is disqualified under section 40(1) and (2) of the Animal Health and Welfare (Scotland) Act 2006.
- A person who is disqualified under section 4(1) of the Dangerous Dogs Act 1991.
- A person who is disqualified under Article 33A of the Dogs (Northern Ireland) Order 1983.
- A person who is disqualified under section 6(2) of the Dangerous Wild Animals Act 1976(8) from keeping a dangerous wild animal.
- A person who is disqualified under section 3(3) of the Breeding of Dogs Act 1973(9) from keeping a breeding establishment for dogs.
- A person who is disqualified under section 4(3) of the Riding Establishments Act 1964(10) from keeping a riding establishment.
- A person who is disqualified under section 3(3) of the Animal Boarding Establishments Act 1963(11) from keeping a boarding establishment for animals.
- A person who is disqualified under section 5(3) of the Pet Animals Act 1951(12) from keeping a pet shop.
- A person who is disqualified under section 1(1) of the Protection of Animals (Amendment) Act 1954(13) from having custody of an animal.
- A person who is disqualified under section 4(2) of the Performing Animals (Regulation) Act 1925(14).
- A person who is disqualified under section 3 of the Protection of Animals Act 1911(15) from the ownership of an animal.
